- **SUBMITTAL OF BIDS:** The WMUA seeks: 1) fixed price, and 2) fixed price with capacity and transmission charge pass through products for terms of 12, 24, 36, and 48 months in accordance with the attached Technical Specification for Electricity Supply. Sample contracts and non-priced bidding forms are due from each interested bidder by mail or courier delivery on Friday, December 11, 2015. Pricing Sheets [per attached Specification] are due by email by 1:00 PM EST on Tuesday, December 15, 2015 to the recipients named in the Specification.
- **WITHDRAWALS OF BIDS:** Bids may be withdrawn on written or telegraphic request received from bidders prior to the time fixed for opening. Negligence on the part of the bidder in preparing bid confers no right for the withdrawal of the bid after it has been opened.
- **BIDDERS PRESENT:** It is not essential for bidders to be present at the bid opening. At the time fixed for the opening of bids, their contents will be made public for the information of bidders and others properly interested, who may be present either in person or by representative.
- **AWARD OF CONTRACT:**

During the performance of this contract, the contractor agrees as follows:

A. MUA Overview

The Willingboro Municipal Utilities Authority [MUA] provides water supply, waste water collection and related services to Willingboro and some surrounding municipalities. Its operation and governance is independent of Township of Willingboro, NJ. The majority of the electric load is associated with pumping and processing potable water and waste water. There are 15 PSE&G electricity accounts which are detailed in a separate, worksheet file [attached]. Additional information about the MUA is available at www.wmua.info.

The MUA has engaged the energy advisory firm 5 to prepare this specification and to assist the evaluation of Supplier proposals received as a result of it. The associated Board Resolution and the other attachments are part of this specification.

B. Key Milestones for This Procurement

1. Supplier sample fixed price w/ capacity and transmission charge pass-through contracts are due by December 11, 2015 by mail or courier delivery [earlier if possible]
2. Supplier questions are due no later than December 11, 2015 via e-mail. [see email addresses below]
3. Sealed bid opening will be in accordance with the attached Instructions to Bidders
4. Contract Award on December 15 by 3:00 PM. Transmittal of executed documents to Supplier to be in **accordance with Supplier's instructions provided in his bid.**
5. Contract acceptance and booking confirmation required from Supplier on December 11 by 4:30 PM
6. Please refer to the end of this specifications for Attachments that form part of this specification.

C. SUPPLY Product & Pricing Specifications

1. Full Fixed Price: The price shall be inclusive of **all** applicable PJM, PSE&G [excluding Delivery charges] and Supplier cost components, fees and charges
2. Fixed Price w/ Capacity and Transmission Pass-Through Supply: As in 1. above except that Capacity and Transmission charges passed through at actual cost to the Supplier
3. Applicable Accounts: All accounts on the attached list with 25 % minimum allowed usage variation [bandwidth]. Variation is to be determined based on aggregate account usage. Accounts deleted subsequent to the execution of the contract will be treated as a change in aggregate usage.
4. Supply Start Date: May, 2016 on the respective account meter read dates of that month

- a. Term of Supply: Suppliers requested to submit pricing and executable contracts for terms of 24, 36 and 48 months. Serious consideration will be given to submittals for each term even if Supplier elects to submit for less than the 3 requested terms.
- b. Selection of the bid for the term most attractive to the MUA will be based on pricing and other factors.
- c. Supplier must include an executable contract for each term for which pricing is submitted to receive consideration for that term.
- d. Supplier shall include **indicative** pricing for a term of 12 months. **NOTE:** This price is **only for planning purposes** and will **NOT** be contracted for as part of this solicitation.

D. Contract Pricing Requirements

1. All cost-of-service components known [or reasonably anticipated] at the time price is submitted shall be included.
 - a. For items specifically excluded from the Fixed Price, with the intent to pass them through at cost [e.g. RMR], reasonable estimated value(s) shall be provided.
 - b. Subsequent charges for costs knowable at the time of the Bid will not be accepted except as defined in 2.a above, and 3. below.
2. Changes in Law/Regulation
 - a. Any subsequent adjustment to the contract price, or other charge, associated with change in law or regulation must be noticed by the Supplier in advance of such charges being invoiced. Full documentation of such charges must accompany the adjustment request.
 - b. The documentation for such adjusted charges shall:
 1. Include reference to the Supplier's Agreement section(s) that provide for the additional charge(s).
 2. Explain the material cost impact on the Supplier of such changes relative to the MUA contract price.
 3. Demonstrate such charges would have applied to any Load Serving Entity and are NOT unique to the Bidder.

E. NJ SUT Requirements

1. The MUA is currently **not exempt** from NJ Sales & Use Tax [SUT] and bid prices must **include** this component.
2. In the event the MUA receives energy SUT exemption during the course of the Supply Agreement, the Supplier shall:
 - a. Be presented evidence by the MUA as to the change in tax status.
 - b. Adjust the billing price going forward from the date the energy SUT exemption is granted.
 - c. Refund the MUA for all SUT collected from the effective date of the SUT exemption certificate or as otherwise stipulated and/or allowed by the NJ Division of Taxation.

F. Payment Terms & Billing

1. The Supplier's price shall reflect the MUA's practice of paying invoices **1 time per month** in accordance with the following cycle:
 - a. The MUA's Board meeting is the 3rd Wednesday of each month.
 - b. Invoices received subsequent to a previous month's Board meeting and prior to 5 days of an upcoming Board meeting are presented for payment approval at the next Board meeting.
 - c. Payment of invoices approved at a Board meeting is generally made within 5 days following that Board meeting.
 - d. Depending upon the day of receipt, this generally results in an invoice for an individual account being paid between **10 and 45 days after receipt**, depending upon its day of receipt.
 - e. Any payment terms contained in the Supplier's contract shall reflect the Supplier's understanding of this payment cycle and shall provide for **no late charges** on any account so

long as payment is made in accordance with the above described process.

PROVIDE ENERGY ADVISORY SERVICES**



3. The notice of this resolution shall be published in the Burlington County Times as prescribed by law.


