## **Discussion:**

R. Trice: Has a contract amendment that would like to be submitted and approved for Well 5A to convert from an oil lubricator pump to a water lubricator pump.

Cmmr. Turner: Asked for the differences be explained.

R. Trice: Responded stating that an oil lubricator is more complicated, requires more maintenance, and other supplies are needed to be ran efficiently.

Cmmr. Evans: Asked would the water lubricator pumps be installed in all of our wells or only in Well 5.

R. Trice: Responded stating that it is already done to Well 11, Well 9, and Well 10 is currently under construction. Also stated that after Well 5 only Well 6 will be left and that will be done as well when the plan is upgraded.

D. Diggs: Asked if this was a part of the NJEIT project.

R. Trice: Yes.

Cmmr. Sills: Asked if the new pumps would be compatible with the new smart meters.

R. Trice: Yes.

Cmmr. Turner: Asked where the decision came about to covert to water lubrication pumps.

J. Mackie: Due to the recent failure at Well 10 and also in the summer of 2012. Also stated that water lubrication system is often used in sites with fairly shallow and static water levels.

R. Trice: Added that most authorities are converting little by little.

Cmmr. Evans: Asked if we are working on the construction of Well 5 now and if so is this a part of the upgrade.

R. Trice: Yes.

A. Weber: Asked would the contract delay the construction.

R. Trice: No.

Cmmr. Turner: Asked if there was time limit.

R. Trice: Responded stating that it does not change the time of the contact which is 1 year.

WHEREAS, the Willingboro Municipal Utilities Authority has complied with the requirements of the Local Public Contracts Law (P.L. 1971, Ch. 198) and received sealed bids for Well 5A Radium Removal Treatment Plant Upgrades on April 27, 2016 and awarded such contract on May 18, 2016, and

WHEREAS, the contract was awarded to MBE Mark III Electric, Inc., and

WHEREAS, the contract required that the existing well pump be replaced with an oil lubricated well pump, and

WHEREAS, the Authority's other well pumps have or will all be replaced with water lubricated pumps, and

WHEREAS, the Authority wishes to have all water lubricated well pumps installed in its system, and

WHEREAS, the contractor was requested to provide a quotation for furnishing a water lubricated well pump in lieu of an oil lubricated well pump, and

WHEREAS, the contractor submitted a quotation for furnishing a water lubricated well pump in the amount of \$12,388.00, and

WHEREAS the Consulting Engineer has reviewed the pricing submitted by the contractor and finds that it is reasonable and is recommending approval of Contract Modification No. 1.

NOW, THEREFORE, BE IT RESOLVED by the Willingboro Municipal Utilities Authority assembled in regular session this 21th day of September 2016 that:

- 1. Contract Modification No. 1 in the amount of \$12,388.00 is approved.

**Whereas**, the infrastructure that brings water and wastewater to and from homes and businesses is essential to the quality of life and economic vitality of the Township of Willingboro; and

**Whereas,** the Willingboro Municipal Utilities Authority serves a number of Communities including the Township of Willingboro, Mt. Laurel Township, Edgewater and Westhampton Township with 240 miles of water and/or sewer mains, with a system that began in 1958;
