CHANGE ORDER NO. 2 TO CONTRACT 2016-4 WELL No. 11 REDEVELOPMENT AND PUMP REPAIR

WHEREAS, the Willingboro Municipal Utilities Authority has complied with the requirements of the Local Public Contracts Law (P.L. 1971, Ch. 198) and received sealed bids for Well No. 11 Redevelopment and Pump Repair on August 12, 2016 and awarded such contract on August 17, 2016, and

WHEREAS, the contract was awarded to Layne Christensen Company (Contractor), and

WHEREAS, it was determined by the Consulting Engineer during the redevelopment phase of the project that the well required additional redevelopment, and

WHEREAS, the Consulting Engineer in consultation with the Contractor determined that an additional four (4) days of redevelopment was needed to effectively clean the well, and

WHEREAS, the Contractor's bid included a unit price of \$1,800.00 per day for redevelopment, which results in an increase in the amount of \$7,200.00 (4 days @ \$1,800.00/day), and

WHEREAS, the Owner requested that the well be televised an additional time at a cost of \$850.00, and

WHEREAS, the Consulting Engineer has reviewed the above pricing and finds that it is reasonable and in accordance with the terms of the Contract and is recommending approval of Contract Change Order No. 2.

NOW, THEREFORE, BE IT RESOLVED by the Willingboro Municipal Utilities Authority assembled in regular session this 17th day of May 2017 that:
