RESOLUTION 2017 – 9-20-3 AUTHORIZING REQUEST FOR PROPOSAL FOR AN ENERGY SERVICES COMPANY TO IMPLEMENT AN ENERGY SAVINGS IMPROVEMENT PROGRAM

WHEREAS, the Willingboro Municipal Utilities Authority ("WMUA) is seeking Proposals from qualified Energy Service Companies (ESCO) for the planning, development and implementation of an Energy Savings Plan through an Energy Savings Improvement Program (ESIP) pursuant to the Energy Savings Improvement Program Law, P.L. 2009, c. 4, N.J.S.A. 40A:11-4.6.; and

WHEREAS, as the first step towards initiating an Energy Savings Improvement Program, the WMUA has participated in the New Jersey Board of Public Utilities' Local Government Energy Audit (LGEA) Program pursuant to the Energy Savings Improvement Program Law, P.L. 2009, c. 4, N.J.S.A. 40A:11-4.6 and has received said LGEA that will be provided within the Request for Proposal (RFP); and

WHEREAS, pursuant to the Energy Savings Improvement Program Law, P.L. 2009, c. 4, N.J.S.A. 40A:11-4.6. the WMUA is utilizing the template RFP for ESCO per the New Jersey Clean Energy Program guidelines to fairly and openly solicit proposals; and

WHEREAS, pursuant to the Energy Savings Improvement Program Law, P.L. 2009, c. 4, N.J.S.A. 40A:11-4.6. the WMUA will select an ESCO partner through the competitive contracting process utilizing the evaluative criteria contained in the RFP; and

WHEREAS, pursuant to the Energy Savings Improvement Program Law, P.L. 2009, c. 4, N.J.S.A. 40A:11-4.6. the WMUA is requiring public advertisement for RFP for ESCO in a manner consistent with New Jersey Board of Public Utility guidelines requiring sufficient time to provide ESCO's a fair opportunity to submit their response; and

WHEREAS, the WMUA has determined that a fair and open process requires that all responses be publicly opened and announced and thereafter the selection of the Energy Services Company be made at a public meeting of the WMUA governing body and then published in accordance with N.J.S.A.40A:11-5.

NOW, THEREFORE, BE IT RESOLVED, AS FOLLOWS:

1. The appointment of the Energy Services Company shall be subject to a fair and open process as set forth below.

- 2. The Executive Director shall cause a legal notice to be published in Burlington County Times and the WMUA website stating that the WMUA is seeking Proposals from qualified Energy Service Companies for the planning, development and implementation of an Energy Savings Plan through an Energy Savings Improvement Program pursuant to the Energy Savings Improvement Program Law, P.L. 2009, c. 4, N.J.S.A. 40A:11-4.6.
- 3. The website posting and newspaper shall inform potential responders that all submissions must be made to the WMUA and received not later than October 13, 2017 5pm.
- 4. Commencing upon receipt, or as soon thereafter as may be possible, the WMUA or its designee(s) shall publicly open and announce all submissions in the WMUA's public meeting room.
- 5. The Commissioners shall thereafter review all submissions.
- 6. Selection shall thereafter be made at a public meeting of the Commissioners no sooner than its November meeting.
- 8. Subsequent to selection, appropriate notices shall be published in accordance with the requirements of N.J.S.A. 40A:11-5.

BE IT FURTHER RESOLVED, that the selected ESCO and the WMUA shall enter into an Investment Grade Audit (IGA) agreement specifying the process for which the Energy Savings Plan shall be collaboratively developed and designed.

BE IT FURTHER RESOLVED, that the Commissioners have determined that the term of this Resolution constitutes a fair and open process.
