WHEREAS, the Authority requested that the contractor provide a price for furnishing and installation of two (2) each replacement modules for the existing surge protection devices, and

WHEREAS, the contractor provided a price in the amount of \$2,240.00, and

WHEREAS the Consulting Engineer is recommending that Contract Modification No. 1, in the amount \$2,240.00 be approved, and
